- hiring external tester performing a "The BITV design support test" ([https://www.bitvtest.eu/bitv\\_test/intro/d.html](https://www.bitvtest.eu/bitv_test/intro/d.html))
- having a constantly growing numbers of customers performing extended accessibility tests based on EU directives (Deutsche Telekom, Allianz, Bundesagentur für Arbeit as some examples) and incorporating feedback as the challenge with accessibility testing that there are a lot of areas where the assessment is more "subjective" than "objective"
